Important Local Act.

**In Relation to the Preservation of Man-
made Land.**

The following local act having passed
both branches of the Legislature, we
signed by the Governor, May 1st, 1878,
is now in a new law:

CHAPTER 381, LAWS OF 1878.
AN ACT FOR THE PRESERVATION OF
THE WILDERNESS LANDS, AND TO
ON THE COUNTY OF SCHUYLER, STEUBEN,
CHEMUNG, SENECA, Yates and Ontario;
The People of the State of New York, R.

Important Local Act.
In Relation to the Preservation of Fish.
 The following local act having passed both branches of the Legislature, was signed by the Governor, May 1st, 1878, and is now a law:

CHAPTER 381, LAWS OF 1878.
AN ACT for the preservation of fish in and about the waters of the State, on the counties of Schuyler, Steuben, Chemung, Seneca, Yates and Ontario.

The People of the State of New York, Represented in Senate and Assembly, do enact:

SECTION 1. No person shall take, procure or catch, or assist in taking, procuring or catching, with only means of an artificial device whatever, except hook and line, or with any other contrivance, except by fair bait, which may be taken with small net, from the waters of Seneca, Cayuga or Oneida lakes, the outlet or inlets, or any canal running into or out of any of the said waters, or any other lakes or rivers into which wholly or partly in the counties of

Section 1. No person shall take, procure or catch, or assist in taking, procuring or catching, with or without arms, any fish, or any other aquatic animal, of any fish of any kind, except minnow for bait, which may be taken with or without arms, in any of the lakes of Canandaigua or Honeoye lakes, the outlets or inlets, or any canal running into or out of said lakes, or from the outlet or inlet of any lake, or from the whole or partly in the counties of Schuyler, Steuben, Seneca, Chautauque, Yates or Otsego, in this State, or either of them, during the month of June, or in ten years from and after the passage of this act; and no person shall take, procure or catch, or assist in taking, from said water any way whatever.

§ 2. Upon complaint, made on oath, by any justice of the peace, against any person, for the violation of any of the provisions of this act, said justice of the peace shall issue his warrant for the arrest of the person charged with the offence, or her or he to be brought before the justice for examination. If it shall appear, by the confession of the offender,

Solomon, Stephen, Seuen, Chetumal, and the other persons named in the foregoing provisions of this act, or of any of their outlets or inlets, within ten years from and after the passage of this act; and no person shall take any money from said water in any way whatever.

S 2. Upon complaint, made on oath to the proper authorities, that any person as herein provided is guilty of any of the provisions of this act, said justice of the peace shall issue his warrant for the arrest of the person named in the complaint or her to be brought before said justice for examination. If it shall appear, by the confession of the offender or by the evidence of others, that she has violated any of the provisions of this act, the justice shall commit her to the county jail for a term of not more than six months and not less than thirty days, or shall impose a fine upon such offender of one hundred dollars, or both such imprisonment and fine, until such fine be paid, but not exceeding thirty days in addition to the time of such imprisonment, to be committed by the justice.

S 3. The fine collected from any offender under the provisions of this act shall be paid to the county treasurer.

she has violated any of the provisions of this act, the justice shall commit such offender to the county jail for no more than thirty days, or shall impose a fine on such offender of one hundred dollars; and the offender shall remain in jail until such fine be paid, but not exceeding thirty days; and shall add one-half to the amount for which he may have been committed by the justice.

§ 3. The fine collected from any offender under the provisions of this act shall be paid to the justice collecting the same, one-half to the county treasurer, to be placed to the credit of the poor fund of the town in which the offender was committed, and one-half to the person making the complaint.

§ 4. It shall be the duty of the sheriff of the aforesaid counties, or any constable of any of the towns in which the same are situated, to take the offender to town to make the complainant described in this act against any person who has committed any offense under the provisions of this act, and it shall be the duty of the

the same, one-half to the county treasurer, to be placed to the credit of the poor fund of the town in which the complainant resides, and the other half to the person making the complaint.

§ 4. It shall be the duty of the sheriff of the aforesaid counties, or any constable of any of the towns in which the complainant resides, to take the town to make the complainant described in this act against any person who in such officer or constable may know or have reason to believe is guilty of this act; and it shall be the duty of the said officer or constable of each town, after trustworthy information, to make such complaint, upon information received from any person, of whose violation of any of the provisions of this act he may have been so informed. In case such officer or constable shall have received trustworthy information derived from another person, he shall pay to such person one-half of the portion of the penalty which he shall have received from the complainant, and the other half shall be paid to the sheriff of the county in which such officer or constable resides.

shall officer or game constable of each town, after trustworthy information, may make such complaint upon proof of such violation of any of the provisions of this act, as shall be made known to him, and in case of such complaint being so formed, in case such officer or game constable shall make the complaint upon information derived from any other person, he shall pay to such person one-half of the portion of the penalty which he shall have received from the violator, and in case of such complaint being made by such officer or game constable, he shall forfeit the penalty of twenty-five dollars, to be paid for each such complaint made by such person in his own name, before a justice of the peace in the county where such officer or game constable resides. § 5. This act shall take effect immediately.
