The Chinese question is again coming into prominence, owing to the fact that while the United States has extended a cordial invitation to the Government of China to participate in our World's Fair, it has taken no steps towards a change in the present laws, which prohibit the landing of citizens of China in this country. It is clear that China will send no exhibit if her people are not allowed to visit the fair. The Treasury Department wants Congress to solve the problem, but nobody has yet made a definite suggestion as to how it may be done satisfactorily to ourselves and the Chinese government.

The Russian Navy. In numbers and in armored tonnage the Russian navy exceeds that of Italy. A large proportion of the Russian fleet is old. Many of these older ships are small and weakly armored. Moreover, some of Russia's recent vessels are armored cruisers of an objectionable type. Still she is a good fourth in the race, and if her present rate of construction continues for a few years longer she is likely to outstrip Italy. A large portion of the new vessels for the Black sea, and in that quarter Russia is the acknowledged mistress. Turkey no longer even attempts to keep pace with her. Three large ships for the Black sea are now actually completed, the Tchesme, the Sindope and the Catharine II.
