There used to be, says a report, a curious oil well in Venango county, Pa., which never yielded a drop of oil except on Sunday, to the great grief of the Sabbatarians. But there is a well in Wheeler canyon, Cal., known as the Lunatic Oil spring, which is quite as curious. When the new moon appears it begins to flow oil, and the flow increases in volume as the moon grows. When the moon is full the spring yields three barrels a day. When the moon reaches its last quarter the flow ceases.

The Columbian "quarter" bids fair to become in course of time the rarest of modern coins, as only 40,000 of them are to be minted. They will be issued to the board of lady managers of the world's fair, who will sell them at a high premium as souvenirs. The coin itself will be a work of art. The full design has not been announced, but the obverse side is to bear the portrait of Queen Isabella, of Spain. One of the special features of the new coin is that it is the first issued by this government to bear the portrait of a woman. Other coins bear idealized representations of the fair sex, but this is the first to be honored by an authentic reproduction of a particular feminine face.

There are a good many ways of going to the world's fair at Chicago. Some wealthy New Yorkers are going in their steam yachts. A boys' school in central New York will make the trip as midshipmen, on board a training ship for the summer. Several persons intend to make the journey on bicycles. But the most enterprising method that has yet come to light is that of the Woodstock guards, of Anniston, Ala., who purpose to march to the national encampment at Chicago. The distance is somewhat over 800 miles, and the soldiers think they can accomplish the march in six or seven weeks. Each man will carry his arms and knapsack, while wagons in charge of the quartermaster sergeant will transport the heavier luggage, cooking utensils, etc. By this trip the guards will not only get to taste the sweets and bitters of a true soldier's life, but will pass leisurely through a long stretch of pretty country. The guards will probably ride home.

## Chautauqua's Defaulting Treasurer Returns.

A dispatch from Jamestown June 2d says: "It is rumored here that Orin Sperry, Chautauqua's defaulting County Treasurer, who has been living in Canada, boarded a train at Mayville Junction today for Jamestown. His return was brought about by the efforts of the Hon. Walter L. Sessions, who is now at his home in Panama, this county, where he is undoubtedly in conference with Sperry. Sperry came to the county today in answer to a telegram from Sessions, who left at four o'clock for his country home at Panama. Sperry will give himself up to the officers of the county and will testify in the cases that are to be brought by the county against Dana P. Horton and Henry R. Case. Sperry was a defaulter about 10 years ago to the amount of about \$80,000. He has been an exile since that time, but claims that others who have since been honored in the county have shared his guilt and his gains. The cases that are to follow will attract great attention. His return is a great surprise to many."

There has been a movement in Chautauqua county to quash the indictments against Sperry. When a reporter saw him in Canada a short time ago, he intimated that he might return to Chautauqua county whether the indictments were quashed or not. This, it seems, he has done. It is also said that a friend who saw Sperry in Canada a few days ago was told by him that he did not intend to remain there much longer. He is tired of being an exile, is an old man now, worn and scarred by the hard battles he has fought since his defalcation, and is ready to take whatever may come through his return to Chautauqua county. He has felt that his age and

his sufferings since the defalcation would count in his favor, and that when the important evidence that he could give in the Horton and Case trials became manifest in court, he believed the criminal actions against himself would be dropped.

## Will Meet at Chautauqua.

The 38th annual convention of the New York State Sunday School Association will be held at Chautauqua on Wednesday, Thursday and Friday, the 28th, 29th and 30th of June. This is the first time the State convention has been held in this delightful resort, which abounds in natural attractions, and is easily reached from all parts of the state. The railroads have agreed to give a rate of one and one-third fare for round trip, and the arrangements for the accommodation of delegates are unsurpassed. 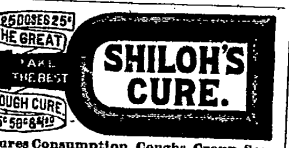

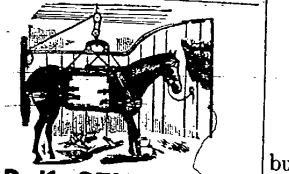
## Notice.
