SUNDAY SCHOOL LESSON

CHRIST AND LIFE AFTER DEATH

International Sunday School Lesson
For April 5, 1942.

Golden Text: "Thanks be to God, who giveth us the victory thru our Lord Jesus Christ." I Cor. 15:57.

Lesson Text: Mark 12:24-27; I Cor. 15:50-58.

With this lesson for Easter Sun-

day, we begin another quarter's study of the life of Christ as recorded in the synoptic gospels, Matthew, Mark and Luke.

Instead of the usual lesson for Easter, the story of the crucifixion, burial and resurrection of our Lord—our lesson for this week concerns what Jesus himself had to say about life after death, a subject in which all peoples everywhere are intensely interested.

The first scripture given for our consideration is an account of an incident which occurred on the last Tuesday of Jesus' life. It was a day of controversy for him in which he was questioned by various sects, not in an effort to gain information, but rather to trap him or to give them cause for having him arrested and put away.

The Pharisees and Herodians wanted to know if it were right for a Jew to pay taxes to the Romans. Any effort to answer directly would involve Jesus in complications, for it would be unpopular to advocate paying the hated taxes and it would be treason to encourage non-payment—either the mob or the Roman authority would be incited against Jesus. The answer given by Jesus did not go into particulars but in general terms defined the proper limits for church and state.

His questioners marveled at the adroitness exhibited. The extent of the hostility to Jesus can be measured by the fact that the Pharisees, intensely patriotic, allied themselves with the Herodians, supporters of the Roman rule. These natural enemies joined in a common hostility to the Galileans.

The Sadducees, the priestly clan, next launched an attack. Unlike the Pharisees, the Sadducees did not believe in the resurrection nor in future rewards or punishments. Their question, therefore, was calculated to point out a complication arising from the doctrine of immortality. Raising a hypothetical question of a woman who had seven husbands on their earth, they wanted to know whose wife would she be in the life to come. Jesus answered by pointing out that the future life was upon a spiritual, not a physical plane, and proceeded to give scriptural reference as to the truth of the resurrection.

"That there is continuity of life is of course implied in the very idea of resurrection; but true life resides not in the flesh, but in the spirit, and therefore the continuity will be a spiritual continuity; and the power of God will effect such changes in the body itself that it will rise out of its fleshly condition into a state of being like that of the angels of God. The thought is the same as that which was afterwards expanded by the apostle Paul in such passages as Rom. 8:5-11, I Cor. 15:35-54. (John Monro Gibson.)

In I Cor. 15:50-58, Paul attempts to describe the transformation of the living and the dead that will take place on the great day of the Lord, when the trumpet will sound. Evidently he thought that the day might come even in his lifetime.

"There have been many discussions about the nature of the spiritual body, the general outcome of which is, as far as Christians are concerned, that its presence in the natural body is the sole rational explanation of human life's mysteries. Biologists and physicians assume its existence and attribute to it mental causation and the healing of certain diseases. Indeed, Gaskell's work on the Involuntary Nervous System argues that there is an intimate association between the two 'bodies'. In the transformation which death affects, God gives the soul a form which pleases him, and adjusts human personality to its new environment," declared S. Parks Cadman.

Dr. Lyman Abbott gives the following confession of his faith: "I believe that death and resurrection are synonymous, that death is the dropping of the body from the spirit that resurrection is the up-springing of the spirit from the body; and I think of my friends and companions, not as lying in the grave waiting for a future resurrection, nor as living in some distant land singing hymns in loveless forgetfulness of those they loved on earth. I think of them as a great cloud of witnesses looking on to see how we fare the race that is set before us, grieved in our failures, glad in our triumphs."

Here's a thought that would be well for all Christians—to ponder now—"The world is like a vestibule before the world to come; prepare thyself in the vestibule that thou mayest enter into the hall."—Rabbi Jacob.

Second Practice Day Blackout Next Monday Evening at the Same Hour, 7 O'clock.

Andover's first practice "blackout" held at 7 o'clock evening, under the direction of Coordinator Mayor George C. Chief Air Raid Warden Charles and Fire Chief George were carried out in a very creditable manner by those participating.

At the sound of the air raid whistle the machinery was shut down, each one at his post, and 29 calls, including ambulance, bomb squads, fire, demolition, and completed in minutes. Of course, this being the first try, a number of records were broken by those who will find the going when they are driving in with heavy red reflectors on their lights.

The auxiliary police, firemen and the Boy Scout members also drew compliments for their manner in which they performed the tasks assigned them.
