Boat Registration Blanks To Be Sent Out To Owners

New York boat owners scheduled to renew their motor boat registration in 1963 should "sit tight" until they receive their official renewal application card from the State Conservation Department.

from the State Conservation Department.

James J O'Brien, Director of the Division of Motor Boats, said this week that an information leaflet explaining how to re-register and the renewal form will be mailed to boat owners 30 days prior to the date on which they are due for reregistration.

The renewal card contains the identical information submitted by the boat owner on his original application in 1959.

Mr. O'Brien cautioned boatmen to carefully read the leaflet and recommended the following steps in filling out the renewal application.

Check the accuracy of the information and correct any errors on the application card;

Fill in the two blanks requesting "County of Residence" and "County of Principal Usage";

Sign the application where indicated;

Enclose a check or money order for the proper reregistration fee:

The age requirement for this position is specified in section 928 of the code of criminal procedure.

Candidates must have been legal residents of New York State for at least four months immediately preceding the examination date.

DUTIES: The duties of Probation Officer are performed, under supervision in the Allegany County Counts. The Probation der supervision. The Allegairy County County Counts. The Probation Officer handles intake, makes probation investigations and supervises individuals placed on probation by the courts. Within the scope of these general duties ar included such specific duties as interviewing, social history taking, gase recording, report preparation, supervision of probationers, and adding probationers in their rehabilitation in various phases of community. Life. As a community representative of his agency, the Probation Officer is responsible for proper interpretations of probation services, cooperation with other community agencies, and good public relations. In addition, he performs other miscellaneous he performs other miscellaneous

Minimum Qualifications: Candidates must meet the following requirement: Minimum Training:

requirement: Minimum Training: graduation by July 1963 from a recognized college or unniversity from a four-year course for which a bachelor's degree is granted.

The law provides that Probation Officers must be selected because of definite qualifications as to character, ability and training, and primarily with respect to their capacity for rightly influencing human behavior. The law further-provides that Probation Officers must be physically, mentally and morally fitted for probation work. Conviction of a felony will bar and conviction of a misdemeanor may conviction of a misdemeanor may bar examination and appointment. A physical examination may be required.

Notice To Owners And Harborers Of Dogs.

Dog licenses for 1962 expired December 31, 1962. The on December 31, 1962. The 1963 license fee was due January 1st. Licenses so issued will cover the period from January to December 31, 1963. Every dog must wear a tag of the current dog license year. A dog without such a tag is not protected by law and no action can be maintained for his injury or destruction.

An unlicensed dog must be

An unlicensed dog, must be seized and killed and the fact that a dog is without a tag is presumptive evidence that the dog is un-

Dog licenses must be obtained from the clerk of the city or town where the dog is harbored or

where the dog is narrored or kept.

License fees: Male Dog, \$2.25;
Female Dog, \$5.25; Spayed Female Dog, \$2.25.34

No license can be issued for less than the full license year.

The owner of a dog, who fails or refuses to obtain a license for the dog as required by law incurs a penalty of \$10.00 and costs.

The enumerators of towns and the police department of cities are required to prepare in January of each year a list of dog owners. The omission of the name of an owner from such lists will not excuse the owner from obtaining a license.
