Only rountine matters confronted the Board of Education of the Greenwood Central School at its regular meeting Monday.

The Board received a report stating that next-fall it would be

stating that next fall it would be necessary to complete tax collection 15 days earlier because of recent legislation. The problem was studied and the Principal asked to contact the assessors and supervisors in each town to see what steps can be taken to comply with the requirement. Because of the earlier time limit, it will be necessary that tax rolls be in the hands of the school at an earlier date than heretofore. There will be no change in the length of time available for paying the taxes since collection has to start earlier to comply with regulations. No apcomply with regulations. comply with regulations. No ap-pointment has yet been made to fill the vacancy of tax collector next July caused by the resigna-tion of Mary Ella Baker. Because of increasing failures

dents and student's time, it was felt that the school should not be involved directly with fund raising for this purpose. It was suggested that perhaps the Home-School Club might be an appropriate organization to carry on this activity if its members were interested. Trickling of requests for an adult class in Driver Education was considered. Because of the change in basis of state apportionment, funds for this would have to come from those intended for operating the school. The Board felt it unwise to undertake the venture at this time.


