# Hit Broadside On Mercy Run

A local ambulance owned and operated by James F. Mulholland was struck broadside Tuesday by a two ton stake truck owned and operated by Marshall Owen, 46, of Akron at the intersection of Rts. 15 and 5 & 20 in East Avon while on a mercy run to the Strong Memorial Hospital in Rochester.

According to Mr. Mulholland and other witnesses the light was green as the ambulance approached the intersection with siren screaming and changed to caution after entering the intersection when it was struck broadside by the truck. Fortunately he was able to keep the ambulance under

able to keep the ambulance under control and manager to avoid hit-ting a State Police car nearby as well as a row of trees at the site.

The infant son of Mr. and Mrs. Ronald Taylor of Andover, in an incubator, was not injured or even awakened by the crash. However the nurse, Sally Florence of Canine nurse, sally riorence of Canisteo, received a bruished right elbow and "Jim" sustained contusions and abraisions of the scalp and lacerations of the left hand.
