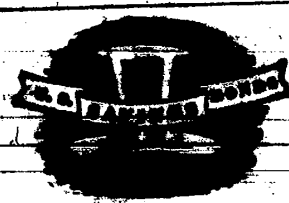

Notice of School Meeting Andover Central School

NOTICE IS HEREBY GIVEN that the annual meeting of the inhabitants of Central School District No. 1 of Andover, Allegany County, qualified to vote at school meeting in said district will be held at the schoolhouse in said district on Tuesday, July 9, 1963 at 8:00 o'clock p. m. for the transaction of such business as is authorized by the Education Law.

And notice is also given that a copy of the statement, of the amount of money which will be required for the ensuing year for school purposes, exclusive of public monies, may be obtained by any taxpayer in the said district during the seven days immediately preceding the annual meeting except Saturday, Sunday or holiday at each of the following schoolhouses in which school is maintained during the hours designated.

And notice is also given that petitions nominating candidates for the office of member of the board of education must be filed with the clerk of the district not later than June 25, 1963.

The following vacancies are to be filled on the Board of Education:
