Last Friday, Gov. Rockefeller lifted most of the ban on hunting with the exception of Sullivan, Ulster, Orange, Rockland, Dutchess, Putnam and Westchester Counties.

The fire danger, which resulted in a record number of forest and brush fires last month, was still considered still too serious in these counties.

these counties. The re-opening of the woods in all other sections meant opening of the big-game season in northern counties and resumption of small-game hunting throughout the state.

Rain, and then the snow fall in this area over the week-end, helped our local area a lot more than it did in most sections.

Harold G. Wilm. Conservation Commissioner said that efforts

hunting seasons curtailed by the closing but that the details have not been fully worked out yet. Mr. Wilm also stated that the

decision to re-open the woods was based on less than optimum conditions", and warned that ex-treme care should be taken to

treme care should be taken to prevent further fires.

Owners of hunting camps in northern counties were cheered by the re-opening of the woods, where the big-game season had been slated to open Oct. 25th.

Allegany County and the surrounding area is scheduled to have the big-game season opened on Nov. 18 and last thru December 3rd.

Reports have come in to date that several area hunters have been successful in bagging them-selves a wild turkey.
