"Bill" Serra Named Allegany County Judge



Governor Rockefeller has appointed William W. Serra, of Belmont as Allegany County Judge mont as Anegany created by resignation of Judge Norman B. Fitzer, according to Robert L. McManus, Press Secretary to the Governor.

Mr. Serra, who has been County Attorney for Allegany since 1952, also will serve as Surrogate and Family Court Judge under his appointment as County Judge until December 31, 1964. Voters will elect a county judge for a full 10 year term next November.

Judge Serra, a Republican, is expected to be the party's candidate for the permanent position in next year's ballotting.

James Sikaras of Wellsville was appointed Monday by the Board of Supervisors to fill the vacancy of Allegany County Attorney created by Mr. Serra's resignation from that post, to take over his duties as County Judge.

"Bill" Serra has practiced law in Allegany County since January 1948 and has been a partner in the law firm of Serra & Serra in Belmont since 1953. His brother, Wesley, has indicated that he will carry on the business alone, since Couny Judges are forbidden to conduct private law practice.

Mr. Serra received a Bachelor of Science degree from City College of New York, a Bachelor of Laws degree from St. John's University and a Doctor of Juridicial Science from Brooklyn Law School.

He served in the U.S. Army from June 1942 to February

He served in the U.S. Army from June 1942 to February 1946, being discharged as an Infantry Major. Presently he is a Lieutenant Colonel. Judge Advocate General Corps, U.S. Army Reserve.

Mr. Serra is also a director of the State-Bank of Belmont and a member of the Canaseraga Advisory Committee of the First Trust Company of Allegany County.

He is a past exalted ruler of the Wellsville Lodge, B.P.O.E.; past master of Melrose Lodge, F.&A. M., Angelica; and has held the presidency of the Allegany County Shrine Club; Belmont Rotary Club; Belmont Industrial Association; Canaseraga Young Republican Club; and is now President of the National Christmas Tree Growers Association Inc. In addition, he is past district governor of the Allegany County Young Republican Club.

New Game Season Dates Announced

Conservation Commissioner Har-old G. Wilm this week extended most game seasons in the State to compensate for lost hunting opportunity as a result of the recendrought-caused closing of New York's woodlands.

"As a general rule, "the Commissioner said, "all seasons have been extended by the number of days lost while the woods and forests were closed. Only cotton-tail rabbit, varying hare and rac-coon seasons have not been lengthened as these seasons nor

Big game hunters in the north-ern zone "lost" eight days dur-ing the woods closure and their ing the woods closure and their season has been extended to Dec. 11. The southern and western zone big game season was unaffected by the shutdown of the woods and the season will run Nov. 18 - Dec. 3. as scheduled. In Westchester County where big game hunting is limited to long bow, the season has been extended to Jan. 1.

Archers, who were able to get in only three days of their special two-week pre-gunning season hunt, will be given 11 days at the close of the regular northern zone big game season. This marks the first time that bow and arrow hunters have had a post season opportunity to hunt deer and bear. The season will run Dec. 12 - 22. 22

Waterfowl hunters in unstate New York and on Long Island will also have their seasons ex-tended as a result of negotiations with the U. S. Fish and Wildlife Service.

Commissioner Wilm said that Commissioner Wilm said that gunning hours, season bag limits and other regulations will remain the same as noted in the Department's "Hunting, Trapping and Fishing Guide."

Waterfowl — ducks and coots (Dec. 21): geese and brant (Jan. 10); rail and gallinules (Nov. 28): woodcock (Dec. 14) and wilson's snipe (Dec. 9).

Small Game for Adirondack Counties (Clinton, Essex, Franklin, Hamilton, St. Lawrence and Warren) — squirrels and ruffed grouse (Jan. 19); Humgarian partridge and pheasant (Nov. 14); cottonical raphit, and recon (Ech. cottontail rabbit and raccon (Feb. 29, not extended): varying hare (Dec. 11, without the aid of dogs in all northern zone big game counties and parts thereof); and, varying hare (Dec. 12 - Feb. 29, with or without dogs).

This means that the average Taxpayer throughout Allegany County will pay around \$2.20 less county tax than last year if his property is assessed at \$5.000.

The amount of decrease will vary in towns, according to their equalization rates. For individual taxpayers, the decrease is only part of the tax picture, because levies for towns and special districts are added to the county levy to make up the tax bill payable in January

to make up the tax bill payable in January.

The total appropriations in the adopted budget is \$3,534,354.11, with largest single expenditures for County Highways and Public Welfare. The budget allocates \$1,299,236.00 to the Highway Department which is well \$1.014. partment which is up \$10,140 for Public Welfare which is up \$23,355.
