Only one day remains to obtain your 1964 registration plate if you want to use your car after mid-night Friday night, the Department of Motor Vehicles reminded New York State motorists.

"And when you make your ap-"And when you make your application, be sure to bring along your Proof, of Insurance (Form FS-1)," said Motor Vehicle Commissioner William S. Hults.

Passenger car registrations must be renewed by February 1, and new plates must be fastened on cars before that date, he pointed out.

Proceeds of this campaign will be used to fight the heart and blood vessel dis-eases, now responsible for more than 54 percent of all deaths in the United States. These diseases. the United States. These diseases include heart attack, stroke and other complications of hardening of the arteries, high blood pressure, rheumatic fever and inborn heart defects and many other heart and blood vessel disorders.

The annual nationwide campaign, which supports the research, education and community service programs of the American Heart Association and its affili-ates and chapters, begins with the opening of Heart Month, February 1. It continues through Fabruary

"I am happy to accept the chairmanship of the 1964 Heart Fund campaign and join actively in this health crusade which is saving hearts in our own community and throughout the na-

saving hearts in our own community and throughout the nation," Mr. Phillips said.

"This assignment is challenging because the Heart Cause is sovery important. It is unique in that it is concerned with a great complex of diseases which constitutes the Number 1 health problem of our time."
