Angela Hugar, three-year-old daughter of Mr. and Mrs. Albert F. Hugar of 476 S. Main St., Wellsvule, proprietors of the "Sugar Shack" here in Andover, is in serious condition at the Strong Memorial Hospital, Rochester, with second and third degree burns sustained Tuesday night, February 11th.

The small youngster was burned on the arms, ribs, back and legs when she tipped a French Fryer containing hot grease on herself. Angela was behind the counter at the Sugar Shack, operated by

The purpose of the caucus was read which was to nominate 2 trustees for the Village of Andover, and for the transaction of such other business as may be iegally Brought before the caucus. The Chairman, Robert A. Baker, announced that the first order of business was to choose a chair-

The Chairman, Robert A. Dan-er, announced that the first order of business was to choose a chair-man, and Charles Ruger nomin-ated James Kessler to act as chair-man, which was seconded by Paul Kilbane. Carried unanimously and James H. Kessler was duly elec-

The Chairman then called for nominations for Glerk, and Hazel Burgett nominated Teresa Mc-Andrew which was seconded by Doris Church. Carried unanimously and Teresa McAndrew was duly elected Clerk.

The Chairman on motion appointed George Sackett and Roger Tuttle as Tellers.

The Chairman then asked for nominations for Trustee to succeed Carlyle Myers. Thereupon Howard E. McAndrew nominated Robert A. Baker as Trustee, on the
