Does Your Operator's License Expire Dec. 30th

If you are one of 600,000 New York State drivers whose operator's license expire on December 31, you will be getting a punch card renewal application in the mail within the next few days.

The Department of Motor Vehiciles began the mailing of the renewal forms a week ago in batches of 120,000 with the last of the 600,000 going out last Friday.
On approximately 200,000 of the applications, drivers due to renew will find the third words, "Eye Test Required," imprinted. This indicates that the driver will be saked for proof that his vision.

"Eye Test Required," imprinted. This indicates that the driver will be asked for proof that his vision meets the State standard of 20/40 in either or both eyes, with or without corrective lenses.

Such proof can be in the form of a certificate from a licensed eye specialist or physician but not an optician, or the applicant may have his eyes tested in a Department issuing office.

You may expect to prove your vision meets the standard if your last name begins with initials "A" through "F" and you are urged by Motor Vehicle Commissioner William S. Hults not to delay going through the renewal process. By doing so early, you can mail the completed application and required renewal stub, also known as the "conviction record", plus the fee_of \$3 to the nearest issuing office. ing office.
