It looks as if we were a little previous in reporting about the metal studded tires or else the State of Pennsylvania was just a little bit ahead of New York State in accepting them.

At any rate, the New York State Public Works Department reported Wednesday that this new type of snow tires with metal studs in the treads may be used on New York State highways from now on. now on.

An amendeent to the department's rules and regulations was filed with the Secretary of State's Office Tuesday to authorize the

The Amendment sets three con-

The Amendment sets three conditions:

1. The studs may not be more than % of an inch in diameter.

2. They may not protrude more than 7/64 of an inch from the tread surface.

3. The total surface area of the studs in contact with the highway at any given time may not exceed 3 per cent of the contact area of the tire.

The department said that, while it generally bars metal-lugged vehicles from New York highways, it decided the new snow tires would not damage pavements because they were designed so that the study wear down at about the same rate as the tire treeds. same rate as the tire treads.
