New Boys In School

The refrain from the song "Love and Marriage" that goes: "You can't have one without the other", applies just as appropriately to the inseparability of federal funds and federal control.

When the national government advances money to a state or a community — for any purpose — it unfailingly marches in with regulatory banners flying even though the money actually comes out of the taxpayer's pockets.

Communities, states and individuals should ponder over the inevitability of having to submit to regulation if they accept federal grants before rushing to support the Administration's aid-to-education plan.

The \$3 billion that will be dispensed under the measure probably looks very enticing to school administrators who may be experiencing difficulty because of low budgets — but — they should ask themselves whether they are willing to accept not one, but two, new boys in their schools - federal grants and regulations.

"ELDERCARE - A Better Plan Than "MEDICARE" An Editorial

The American Medical Association has offered Congress a program of health care for the elderly which merits thoughtful consideration by members of Congress who are sincerely interested in helping people over 65 who need help with their medical expenses.

This new program advanced by the nation's doctors has many advantages over the controversial medicare tax program which Congress has repeatedly rejected over the past six years.

The Doctors' Eldercare Program, because it would be administered by the states, should have particular appeal to the many Americans who are becoming alarmed over the increasing trend toward destruction of our federal system of government.

The AMA plan would employ the machinery of the existing state-administered Kerr-Mills program. It would, in fact, enlarge on this program, strengthen it and make it easier for the elderly to qualify for benefits. Furthermore, it would minimize government involvement in the practice of medicine by providing benefits through private insurance agencies. One of the serious objections to the medicare tax program has been that it would permit bureaucratic interference with doctors and hospitals to the detriment of patients.

To cualify for a policy of health insurance covering a wide range of "ospital and medical benefits under the doctors" plan, an elderly person would simply file a statement of income with a state agency. If his income is below a minimum established by the

Income Tax Tips

"Don't forget to include that

"Don't forget to include that extra income when you prepare your 1964 Federal tax return," Buffalo Internal Revenue District Director John E. Foley, reminded taxpayers today.

He pointed out that interest on savings accounts and U. S. savings bonds, tips, most dividends, and profits from hobbies and from sales of property are all taxable income. Taxpayers should read the form and instructions which dist various items of income that must be reported.

As a general rule, all incomefrom all sources is taxable, unless specifically excepted by law.

Taxpayers who fail to report all taxable income will have to pay any additional tax due as well as interest of 6½. They may also be subject to penalties.

Modern electronic equipment is now being installed by Internal Revenue to help ensure accurate reporting of taxable income.
