To some observers the annual battle of Albany is over before it had a chance to begin.

This is based on the fact that This is based on the fact that the three men who run things in the state Capitol during the legislative session, Governor Rockefeller, Assembly Speaker Perry B. Duryea Jr. of Montauk and Senate Majority Leader Earl W. Brydges of Niagara Falls, have said they will approve the restoration of enough funds in the coming state budget to make up what the local school districts around the state would have lost this year in state aid. state aid.

state aid.

Last year the legislature not only cut back state aid for schools that year, but for this year also. Such a move will cost about \$150 million this year — but about \$300 million more in 1971.

Costs always double the second year of an increase in state aid because of the difference in the beginning of fiscal budget years for the state and the school districts. State fiscal year begins Arril 1. But school fiscal years begin six months later in September, so the

state only has to come up with six months of state aid the first time around.

The leaders have also agreed to hike the flat grant to welfare re-

cipients.
And there goes the two biggest issues of the session.

Abortion reform will get nowhere this year, for the same reason that a lot of other proposals wont go anywhere — this is an election year for the governor and the legislators. They will not risk the loss of the Catholic vote by passing an shortion reform passing an abortion reform

bill.

By the same token they will not risk the Jewish and Protestant vote by passing legislation giving state aid directly to parochial schools.

The best guessers say next year's budget will reach a new record of about \$7 billion. The leaders have pledged themselves to no tax hikes.

But they are remarkably silent

But they are remarkably silent on whether or not it might be possible to have a tax REDUCTION this year.

### Withholding Tax Rates And Tables

The Internal Reven... Service assured employers today that preparations are being made to furnish, at the earliest possible date, the rates and tables to be used for withholding income tax from wages of employees paid on and after January 1, 1970.

Computer runs have already been made to determine the rates been made to determine the rates and tables which would be pres-cribed if Congress and the Presi-dent approve the withholding pro-visions agreed upon by the House and Senate Conferees on the Tax Reform Act of 1969 (H.R. 13270), John E. Foley, District Director, Internal Revenue Service, Buffalo has announced has announced.

has announced.

If these provisions become law, the seven Regional Internal Revenue Service Centers will, as soon as possible thereafter, mail individual copies of the rates and tables to each of the 4.5 million employers who withhold income taxes. The rates and tables will be according to 2.4 mag. Service will work the control of the be issued as a 24-page supplement to the regular Employer's Tax Guide (Circular E).

The new bill, as approved by the conferees, introduces a low income allowance and would reduce come allowance and would reduce the surcharge portion of the with-holding tax from 10 percent to 5 percent between January 1 and June 30. It also would eliminate the surcharge altogether from withholding starting July 1. Before that employers will be mailed a completely revised Circular E containing updated instructions as well as post — July 1 rates and tables. well as post -tables.

The Internal Revenue Service recognizes that some employers recognizes that some employers may not have adequate time to prepare for the January 1 change-over in withholding. Therefore, employers are urged to do their best in installing the new rates and tables as soon, as possible. Good faith efforts to do so will be accepted as substantial compliance with the law, Mr. Foley said.
