## LIVING UNDER LAW

Mrs. Brown, who lived alone in a large residential section of town



would not al-ow her to sell any of them or to let any go. Soon, Mrs. Brown had more than 40 cats living in her home.

Mrs. Brown's neighbors, protesting that the cats made nuch noise at night and aused obnoxious odors, said the animals were a nuisance ind asked the court to restrain her from keeping so many pets.

Mrs. Brown replied that she kept the cats safely and securely confined and in an extremely sanitary manner. She said every cat was in a perfect state of health, well-fed and happy. Mrs. Brown wanted to see them kept and cared for in a proper way and feared that others might not take the trouble to care for them as she did.

She also said she had a right to keep her cats, and that what she did on her own premises was her own business. After all, wasn't her home her castle?

The keeping of cats or dogs in a person's home is certainly a right of every property owner. However, you cannot use your property in such a manner that it unreasonably interferes with your neigh-bors in the use and enjoyment of their property.

Any activity, even the keeping of cats, which impairs the enjoyment of homes in the entire neighborhood and which infringes upon the well being, comfort, repose and enjoyment of a considerable number of persons residing in your neighborhood may amount to a public nuisance. As such it could be enjoined by the courts.
