Interest Deductions Wrong On Many Returns

Taxpayers planning to claim an interest deduction on their 1969 Federal tax return should be sure to read the instructions carefully to avoid errors, John E. Foley, District Director, Internal Revenue Service, Buffalo, said today.

Interest deductions should be entered with other itemized deductions on Schedule A, a separate form this year, and attached to Form 1040. The separate form for itemized deductions gives taxpayers more space than previously provided to list interest, taxes, contributions and other deductible expenses.

Interest paid on a home mortgage, a bank loan or other debt may be deducted if the taxpayer is legally responsible for the payment.

Interest paid for another person is not deductible, Mr. Foley said. This could occur when a parent makes a mortgage payment for his children on a home that is not in his name.

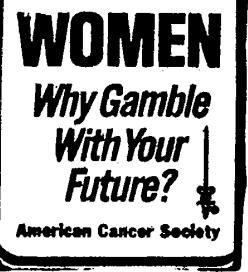
