PROPOSED AMENDMENT NUMBER SIXTERY CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

Proposing an amendment to section five of article eight of the constitution, in relation to indebtedness contracted for the construction or reconstruction of facilities for the conveyance, treatment and disposal of sew-

Section 1. Resolved (if the Senate concur). That subdivision E of section five of article eight of the constitution be amended to read as follows:

E. Indebtedness contracted [on or after January first, nineteen hundred sixty-two and prior to January first, nineteen hundred seventy-three,] for the construction or reconstruction of facilities for the conveyance treatment and tion or reconstruction of facilities for the conveyance, treatment and disposal of sewage. The legislature shall prescribe the method by which and the terms and conditions under which the amount of any such indebtedness to be excluded shall be determined and no such indebtedness shall be excluded except in accordance with such determination.

5. 2 Resolved (if the Senate.

§ 2. Resolved if the Senate-concur), That the foregoing amend-ment be referred to the first regular legislative session convening after the next succeeding general election of members of the assembly, and, in conformity with sec-tion one of article nineteen of the constitution, be published for three months previous to the time of such election.
