Fireworks Fly At Print To Fit Village Board Meeting Monday

Fireworks really flew at the reg-ular meeting of the Andover Vil-lage Board as the discussion over Cable TV in Andover got under way, with several questions going unanswered.

In addition to the four members of the Village Brand with Mover

In addition to the four members of the Village Board, with Mayor James Mulholland out of town on business. Village Employees and the Andover News Editor, several members of the 3-Way TV System were in attendance as well as a representative of Allegany Video Cable System and other Andover residents. No representative from the Addison Cable TV system was present.

Acting Mayor Robert Baker op-ened the meeting, with the minutes Acting Mayor Robert Baker opened the meeting, with the minutes of the previous meeting read and duly approved. He then read the results of the unofficial TV preference poll which showed the following results: from the total of approximately 260 subscribers of the Addison Cable TV System, 92 coupons had been presented with 66 indicating they would go along with a price raise to the proposed rates of \$5.50 per month: 24 members would prefer to change to the 3-way System, and 2 people wanted no change or raise.

As far as the 3-Way System was concerned, from a total of around 150 members. 46 coupons were present with 40 members desiring to stay on the system; and 6 members wishing to subscribe to the proposed new system.

The discussion became heated when the representative from the Allegany System flatly stated that he expected that the 3-Way System would have to move the position of their cable from their present lo-

would have to move the position of their cable from their present lo-cation on the Village Electric Poles

cation on the Village Electric Poles
— at their own expense — if it
interfered with where they wanted
to run their new cable.

When asked how they intended
to make the proposed new system
financially feasable, he stated that
they would initiate an Intensive
subscription campaign by houseto-house canvass and by advertising. During the discussion on the
proposed rate increase to \$5.00 a. proposed rate increase to \$5.00 a month, he was asked if he could promise that there wouldn't be another request for raise in rates in other request for raise in rates in the near future and he stated that he couldn't make such a promise as he couldn't forsee what the future might bring. When asked by a Board Member what action would be taken by his firm if the request for a rate raise from the Village Board was refused — with no answer given.

At the close of the discussion on the TV situation, the Andover News Editor noticed that it appeared as if the Allegany Video TV representative had a tope recorder in ed as if the Allegany Video TV representative had a tape recorder in operation, and when questioned about it, admitted) that he had taped the whole discussion. When an objection was raised as to the use of this recording without the consent of Village Taxpayers in attendance, Mr. John Oliver Baker, Allegany Video representative, stated that he would make a copy available upon request. He then asked the Boards' decision on his firm's request for an increase in asked the loards decision in his firm's request for an increase in rates to \$5.50 and was told that it would have to be taken under further study and that he would be notified in a few days of their decision. decision

In other business under discussion, a local Taxpayer reported that his young daughter was badly that his young daughter was bodly frightened on her way home from school by a large, strange dog and asked what action could be taken to prevent small children from being frightened or even attacked by any of the presently large dog pack that is roving around town.

The answer to this question is: "that the quarantine on dogs in Allegany County is still in effect and that owners must keep their dogs on their own property or on a leash — or else be subject to the penalties of the quarantine law".
