## Snowmobile News From N.Y. Dept. Of Parks

Snowmobiling is a family sport and every family sport should be safe for every member of the family participating in it.

To assure this, New York State is arranging courses in the safe operation of snowmobiles for the younger members of families thru out the state.

This course will consist of four one-hour sessions according to Parks and Recreation Commissioner Sal L. Prezioso and will be conducted by volunteer instructors. There will be no charge to the students. The work book and manual as well as the instructor's material will be provided by the Division of Marine and Recreational Vehicles whose Education and Safety Bureau is handling the training operation.

Attending the four classes and passing the final exam is required, as of October 1, 1971, for any youngster between the ages of ten to 16 who wants to operate a snowmobile by himself. Under the snowmobile law now in effect such young operators must have their snowmobile safety certificate and the four-hour course is the only way to earn it.

Youngsters under the age of 16 who do not hold a snowmobile safety certificate may operate a snowmobile after that date only on lands owned or leased by his parents or guardian. In this case he may operate the sled by himself.

Leased lands, in this instance does not include lands leased by an organization of which the parents, guardian or operator is a member.

On October first snowmobile owners throughout New York State may start registering their sleds with the Division of Marine and Recreational Vehicles of Parks and Recreation. The registration, required under the "snowmobile law" passed at the last session of the Legislature, requires that all snowmobiles in the state must be registered by January 1, 1971.

According to Parks and Recreation Commissioner Sal J. Prezioso the first appearance of the registration forms will be in the hands of snowmobile dealers who are listed with the Division, County Clerks and Motor Vehicle Offices. There will be supplied with a quantity of the registration forms, information on how to register snowmobiles, summaries of the rules and regulations covering their operation, and envelopes in which the sled owners can send their registration application in to Albany.

The Annual Fee for snowmobile registration will be five dollars. Upon registering a sled the owner will receive his registration certificate, the validating decals for attachment to each side of the cowl of his sled, and learn the permanent number which will stay with the snowmobile through its existence.

The registration fee will not only cover the cost of the materials and the registration operation, but will in part be returned to the area to help defray the cost of enforcement of the snowmobile law by local law enforcement agencies.

## Identification Cards To Be Issued October 6th

The Allegany County Sheriff's Department will start issuing Identification Cards to persons 18 years of age or older commencing October 6th, 1970 at Fillmore, N. Y., in the Town and Village Hall between the hours of 4 and 9 P. M.

Persons wishing to obtain these cards must bring a Birth or Baptismal Certificate and those between 18 and 21 be accompanied by a parent or have a Notarized consent. If possible it is asked that the Blood Type be given.

The cost of the card is \$2.00, all of which goes to the Company that will process the cards.

One of the purposes of the I. D. Cards is to help dispensers of Alcoholic Beverages to be sure that a person is of legal age to make purchases.

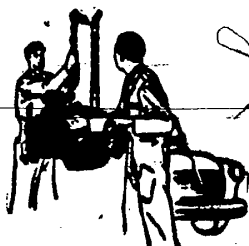
