Benjamin Harris, a publisher who had fled England after imprisonment for printing a seditious pamphlet, put out in Boston a journal, Entitled Buffick Occurrences Both Foreign and Domestick." Waterfowl Season Now Open

October 5, the opening day of the waterfowl season in most of New York, is now upon us Exceptions to this date are Long Island, with its more moderate and later migrations, where the season opens on November 16, and on Lake Champlain, where the season opens on October 10 to coincide with that of Vermont across the Lake.

For geese and brant, October 5 marks the beginning of a straight season running through December 13. For the remaining waterfowl it is a split season with the first part ending on November 18 and resuming for a 15-day hunt December 19 through January 2.
Inclusion of two species of ducks, scaup and blue-winged teal, as bonus birds offers those who can identify waterfowl before they shoot, the possibility of some extra hunting after they get their daily limit of three ducks.

The blue-winged teal is an early migrant and often moves south before the season gets well underway. Because of this, it has taken less than its share of hunting pressure and its numbers have increased Experimental early sea

less than its share of hunting pressure and its numbers have increased. Experimental early seasons in the midwest were successful in harvesting more surplus teal, but also resulted in other protected ducks being killed by hunters who shot first and identified later. During the first nine days of the season. October 5 - 13, two blue-winged teal may be in the hunter's bag in addition to the regular limit of ducks. Four of these teal may be possessed in addition to the regular possession limit during this same time.

The other bonus bird is the scaup. Anytime during both sections of the split season the hunter may have a daily bonus limit of two scaup and a bonus possession limit of four scaup. This is not an across-the-board season, for there are specific waters where these bonus birds may be taken. Generally they can be described as the large upstate waters outside the Forest Preserve: there are some exceptions like Cross Lake and Otsego Lake, so one should confirm local waters before taking bonus scaup. On Lake Champlain the bonus bag for scaup occurs only during November 1 - 28, while on Long Island there is a special scaup season running from January 9 - 24.

Special reduced bag limits still apply to certain species of waterfowl whose reduced populations cannot tolerate the full pressure of a completely open season. These daily bag limits are no more than one black duck, two wood ducks and one can are redhead, and possession limits of no more than two blacks, four woodies and one can or redhead. On Lake Champlain and Long Island, the daily limit is two blacks, with no more than four in possession.

Bag limits for the less-sought-after waterfowl are higher: merbanser — five daily and 10 in possession: scoter, eider and old-squaw — seven daily and 14 in possession: coots — 15 daily and 30 in possession: coots — 15 daily and and rare bird, is given protection and only one may be included in the daily merganser limit. For the hooded merganser, which is an attractive and rare bird, is given protection and only one may be included in the merganser possession limit.

Of the waterfowl? geese are doing the best. The sensational flights of Canada geese that pass up thru Central and Western New York to thrill the goosewatchers in early April, return in forca in October.
