Well Folks - here is something that should be of particular interest to all of you PARENTS—especially with Hallowe'en just around the corner.

In a recent News Release, Assemblyman Frank Walkley (R-Castile) said that as a result of new legislation passed this year, parents should be reminded that they can be held liable for their children's pranks this Hallowe'en, and that it is more significant than in provious years previous years.

"This year a parent or legal guardian of a child over 10 and under 18 can be held liable for the child's willful, malicious or unlawful destruction of property, up to a limit of \$500." The legislation also allows a court to order as a court allows a court to order, as a condition of probation of the child, restitution of damage costs up to \$500 out of the child's own funds, or services for the public good by

or services for the public good by the child.

Assemblyman Walkley went on to say. "it might he wise for parents to have a full understanding of the law as it might apply directly to them as a result of their children's pranks. I would urge all parents to know where their children are this Halloween."

parents to know where their children, are this Hallowe'en."

To the above last statement we add a hearty "Amen". Furthermore, we take more than a dim view of irresponsible parents who "indulge" their "playful" children by allowing them to go out evenings in advance of Hallowe'en and soap up windshields of cars so heavily it is practically impossible for the motorist to see thru it to be able to drive home.

A motorist doesn't normally carry a razor-blade scraper or hot soapy water around in his car to clean a windshield with — and of course our local service stations don't stay open late in the evenings to take care of this type of service. We imagine that under this new law, parents could be held responsible for damages caused in case of an accident caused by the above "so-called" innocent prank!

And, while on the Hallowe'en subject, here are a few words of warning from Dr. Hollis S. Ingraham, State Health Commissioner:

— Young children should be supervised by adults. Children of all ages should be, taught not to

Provided by adults. Children of all ages should be taught not to enter stranger's homes nor to follow them anywhere.

Hand-held flashlights and re-

low them anywhere.

— Hand-held flashlights and reflective tape sewn to costumes will increase children's visibility to motorists.

— Costumes should be fire-resistant, and children should not be allowed to carry matches, candles, or other open flames.

— Masks or other facial disguises should not restrict vision or breathing and costumes should be short enough to prevent tripping.

— Last, but not least, Children should not eat any of their collected goodies until they have been examined carefully by an adult. (In recent years, pins, razor blades slivers of glass and poison have appeared in the treats gathered by children across New York State.)

And, from our standpoint of view an extra warning should be added — for small children to stay away from gangs of large boys — or they may end us as the butt of a practical joke that could have a tragic ending.
