Notice To Harborers Or Owners Of Dogs

Dog Licenses are due January 1st, 1971. They may be obtained at the Town-Clerk's Office.

The law requires that dogs be licensed by January 1. Failure to obtain a license subjects the owner to a penalty of \$10.00 and costs and the dog is liable to seizure.

The Commissioner of Health has issued an order requiring all dogs.

The Commissioner of Health has issued an order requiring all dogs ix months of age or over in the county to be vaccinated to prevent rabies. Therefore, an applicant for a dog license must present to the clerk a certificate certified by a duly licensed veterinarian showing that the dog has been so vaccinated

cinated.

To be acceptable the certificate resented must show that a modified live virus vaccine was used within the four years immediately preceding the application date, or that killed vaccine of brain tissue origin was used within the year immediately preceding the application date.

the clerk, the vaccination certificate must accompany your application and check.
