Notice Of Public Hearing

NOTICE IS HEREBY GIVEN that a public hearing is to be held in the County Legislators' Room in the County Court House, Belmont, New York, on March 12, 1973 at 1:30 P. M. in connection with a proposed local law to amend local law number four of nineteen hundred seventy-one, entitled "A Local Law to Provide for a Partial Tax Exemption of Real Property Owned by Certain Persons with Limited Income who are Sixty-Five Years of Age or Over" in relation to income eligibility requirement.

Such local law proposes to amend subdivision b of section two of local law no. 4 of 1971, to read as follows:

b. The income of the owner or the combined income of the owners or the combined income of husband and wife where title is vested in either the husband or wife must not exceed three thousand six hundred dollars for the income tax year immediately preceding the date that the application is filed.

Such local law, if adopted, will take effect on the date it is filed in the office of the Secretary of State.
