How many of you remember the story of how a battle was - "all for the lack of a horse-shoe nail"?

Many times we have heard people say in the past: "my one vote doesn't matter so why should I vote" Do you realize that in the neighboring Community of Bolivar for two (2) successive elections that a contest for Mayor or Village Trustee has ended up in a tie vote - and has been decided by the toss of a coin? Not Once - but in 2 recent successive elections! And, if you doubt the veracity of this statement, just pick up the phone and ask Ed Mergler, the ex-District Attorney of Allegany County who called it to our attention reand find out for yourself!

Next Tuesday, March 20th, we have an important Village Election coming up. For the first time in around 30 years, according to our memory, we have more than two complete slates of Candidates to select from. Our great Country of America has flourished under the two-party system where we, the Citizens and Voters, had a choice to make at the polls. If we didn't like what went on in our type of Democracy — we have been able to say so at election time by voting in new candidates. This year, on our own local "home front" we have a choice! Let's see if we can't get all local eligible voters out to the polls to cast their ballots for "the ('andidates of their Choice".

ings by voting it down by exactly a 6 to 1 majority. But, how do we know that these same people won't revive the issue - - if they are re-elected?

We again expressed our views about the liberal handling and use of the Village Police car on "out of town jaunts" — which are apparently "not in the line of police duty" but were told that: "they aren't going to run this lad out of town". And, the Police Car continues to make its regular "food runs" to Wellsville and is seen almost nightly by Andover and Wellsville residents! We even disagreed about ordering bills paid without reading them itemized — but it was done when disc brakes were put on the old police car—and Village Board Members denied to us that it had

ALBANY open line

With the session in Albany more than two months old, the Legisla-ture has left the impression, at least, of having done almost noth-

Even the governor has yet to file all of the major program bills he promised in his January message

promised in his January message to the Legislature.

The Senators and Assemblymen have been on a three-day session week for all this time, and, except for the no-fault auto insurance bill, have been passing minor legislation. Legislative leaders are quick to reply that their forces—have been putting in full weeks, attending committee meetings, hearings and conferences, when they are not in the chambers.

Republican Assemblyman John W. Beckman of Chautauqua County has introduced a package of bills aimed at meeting the spring flood crisis expected along the shores of Lake Erie and Ontario.

The threat of flooding and erosion is the result of record high water levels in the Great Lakes

Two of Beckman's bills would provide tax abatement and rebates for victims of flooding.

Local taxing districts would be allowed to allow abatements of up to 100 per cent the first year. up to to 100 per cent the first year. Up to 50 per cent the second year, and 25 per cent the third year. The local taxing units would be paid the loss from state funds.

Another bill would do the same thing with respect to sales taxes.
