

State Veteran Counselor James J. McLaughin today called on veterans to review the beneficiary designations on their GI insurance policies to make certain the listings are up-to-date and provide for payment of proceeds in accordance with their wishes.

Many veterans, the counselor advised, fail to check their policies to be sure beneficiary listings are correct. Consequently, family members receive nothing, in some instances, when a veteran dies. The proceeds, he said, go to outdated listings of beneficiaries which may include old service buddles or girlfriends, since the VA must pay the beneficiaries of record.
