Notice Of Adoption Of Village Ordinance On Dogs

At a special meeting of the Board of Trustees of the Village of Andover, held in the Village Office, Andover, New York on Wednesday evering, September 26th, 1973, after a public hearing held as required by Law. of which due notice was published in the Andover News, the following ordinance was adopted on Control of Dogs within the Village of Andover, Ailegany County, N. Y.

It is ordained and adopted by the Board of Trustees of the Vil-

the Board of Trustees of the Vil-lage of Andover as follows: The following is a copy of the proposed Dog Control Ordinance of the Village of Andover:

ARTICLE I

Prohibited at large unless leashed

(a) No person owning or having custody and control of a dog shall permit such dog to be at large in the village, elsewhere than on the premises of the owner, except it be on the premises of another person with the knowledge and consent of such other person.

(b) The owner or person having the custody and control of a dog in the village, which is not on the

in the village, which is not on the premises of the owner or upon the premises of another person with the knowledge and consent of such person, shall control and restrain such dog by a leash.

(c) The fact that a dog is at large in the village, elsewhere than on the premises of the owner shall be presumptive evidence that the dog has been permitted to be at large with the knowledge of the owner or person having custody and control of the dog.

Seizure of unleased dogs —

Seizure of unleased dogs Alternative to seizure

(a) Dogs which are not restrained by leash and which are off the premises of the owner and are the premises of the owner and are upon the premises of another person without the knowledge and consent of such person, may be seized as hereinafter provided, or in the alternative, the dog warden or anyone duly authorized by the chief of police to enforce this article may issue a summons to the owner alleging a violation of this article and directing said person to appear before the village justice at a time and date indicated thereon to answer said charge.

(b) Ownership to a dog may be

(b) Ownership to a dog may be proven by its dog tag number. Such identification shall be presumptive evidence of its owner

ARTICLE 11 Definitions -

As used in this article, unless the conext otherwise indicates, the following words, terms and phrases shall have the meanings herein ascribed to them:

At large — A dog shall be deemed to be at large if off the premises of its owner and not restrained by a leash.

Dog Warden — Any person appointed by the mayor to assist in the enforcement of this article and Article 7 of the Agriculture and Markets Law of the State of New

York as therein specified.

Owner — Any person having the right of property in a dog and any person who keeps or harbors a dog or has a dog in his care or who acts as its custodian.

ARTICLE III Seizure of unlicensed,

untagged Dogs

(a) The dog warden or any of (a) The dog warden or any of his duly authorized assistants and the duly authorized agents of any person or corporation enforcing the Agriculture and Markets Law and the Public Health Law relating to dogs shall seize any unlicensed dog either on or off the owner's premises. This will not apply to a dog under the age of six (6) months which is not at large.

(b) Any dog warden or such representative shall seize any dog found at large not wearing a license.

(c) The fact that a dog is with-

(c) The fact that a dog is with-out a tag attached to a collar as provided by law shall be presumptive evidence that the dog is un-

ARTICLE IV

Disposition of unlicensed untagged Dogs

Every dog seized as provided in Article III shall be dealt with pursuant to Section 114 of the Agriculture and Market Law of the State of New York which provides for the seizure and redemption of dogs so seized.

ARTICLE V Penalties

A violation of this article shall be an offense and shall be punish-able by a fine of not less than twenty-five dollars \$25,000 nor more than one hundred dollars (\$100.00) or by imprisonment for not more than fifteen (15) days or by both such fine and imprison-
