Contract**

A PUBLIC HEARING will be held at the Town Hall on W. Center Street, Andover, N. Y., on Friday, December 28th, 1973, at 7:30 P. M., on the proposed Fire Protection Contract between the Town of Andover and the Village of Andover as parties of the first part, and the Andover Fire Department Inc., party of the second part.

Under the said proposed Fire Protection Contract the Village of Andover and the Town of Andover are each to pay the Andover Fire Department Inc., the sum of Four Thousand Dollars (\$4,000.00) a year for a term of five (5) years being a total sum of eight Thousand Dollars (\$8,000.00), a year.

Under the terms of said Fire Protection Contract, the said Four Thousand Dollars (\$4,000.00), a year to be paid by the Town of Andover is to be paid directly to the Village of Andover, who in turn will then pay Eight Thousand Dollars (\$8,000.00), a year directly to the Andover Fire Department Inc.

Said Fire Protection Contract to be for a five (5) year term beginning January 1st, 1974, to December 31st, 1978.

The Andover Fire Department Inc., on its part agrees to supply fire protection both to the Village of Andover and the Town of Andover and supply its own fire fighting equipment and maintain a volunteer fire department with sufficient members to supply fire protection to the Village of Andover and the Town of Andover.
