Legislator Lee Ryan Reports

Part II of New County Office Building Addition

Having received the revised estimate of \$3,990,069 for the new building addition, the Board of Legislators directed the (Special Legislators directed the (Special Bullding Committee) to study ways of financing the construction. Financial consultants were interviewed to assist us. Present information indicates that if the entire amount were to be bonded (which is attilizely), the first year property tax rate would have to be raised anywhere from a high of \$5.41 per thousand for a front loaned 20 year bond to a low of \$3.97 per thousand thousand for a front loaned 20 year bond to a low of \$3.97 per thousand for a rear-loaned 30 year housand The low initial tax rate would result in additional-interest payments of approximately \$2.000,000 over, the term of the bonds

over, the term of the bonds

If the amount to be raised through the sale of bonds were to be decreased by a million by budgeting \$330,000 to the capita, reserve fund account for three years, the resultant tax rate increases would be a high of \$4.21 per thoursand on the front loaded 20 year bond to a low of \$3.25 per thousand on the rear-loaded 30 year bond. These tax rates would decrease yearly as principal wareduced. reduced.

Property tax rate could be fur-ther lowered by other means Revenue sharing and surplus funds could all be considered in reduccould all be considered in reducing debt. Another suggested way in avoiding a property tax hike would be through an increase in the County sales tax from two to three percent. I am sure there will be a lot of thought given to financing if we proceed with the new addition.

The present Highway building could be utilized as a Mental Health Center.

The recommendations of the (Special Buildings Committee) are 1. The architect be directed to

2. The County direct the architect to proceed with the design for an office building as described above, with an option for one blank floor to be bid separately.
3. The Special Buildings Committee be authorized to engage a

mittee be authorized to engage a financial advisor to work with the Committee for financing construc-

tion.

This is pretty much the picture of the (New Building Addition.)
Up to this point the whole Board of Legislators have supported the concept of the need for either new or reconstructed jail facilities and additional space for other departments that have been mentioned. Public reaction will certainly play a part on the decisions that the Legislators must face.

The ground floor would contain the Sheriff's Office, the jail kitchen, a prison elevator, the Civil Defense Emergency operating center (50% Federal funding) and the Public Health Nursing Service (or Health Department when created.)

The first floor would be almost all Social Services. Some excess space exists for future expansion or for use of some of the smaller County operations.

The second floor would contain the Board of Legislators, the Coun-

Attorney, the Highway Department and the Department of Plan-

The third floor would be the jail. including the necessary functions required by the Commission of Correction. Initial construction would provide 35 cells with an ultimate capacity of 50 to 60.

The main onange in the present court house would be in devoting the entire second floor to the

courts.

One of the problems that we have One of the problems that we have been confronted with is the use of the old County Home and Infirmary in Angelica. We have met with the County United States Department of Agriculture Agencies (SCS, FHA, ASCS.) Cooperative Extension and the NYS Department of Environmental Conservation with the idea of converting the building into a Farm and Home Service Center. To date no decision has been carried.
