Section 1. The specific object or purpose of the Village of Andover, Allegany County, New York, for which the serial bonds herein authorized are to be issued is the acquisition and installation of new substitution authorized as a part

acquisition and installation of new substation equipment as a part of the electric distribution system of said Village at Maple St., Andover, New York.

Section 2. The maximum estimated cost of the aforesaid specific object or purpose is \$100.000, and the plan for the financing thereof is by the issuance of \$100,000 serial bonds of said Village, hereby authorized to be issued pursuant to the Local Finance Law.

a) The period of probable usefulness applicable to the aforesaid specific object or purpose is thirty years, pursuant to subdivision 5 of paragraph a of Section 11.00 of the Local Finance Law.

b) The maximum maturity of the serial bonds herein authorized to be issued will exceed five years.

c) No down payment is required pursuant to the provisions of subdivision 3 (d) of paragraph d of Section 107.00 of the Local Finance Law.

Section 4. The faith and credit of said Village of Andover, Allegany County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such bonds as the same respectively become due and payable An annual rppropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property in said Village a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Subject to the provisions of the Local Finance Law. the power to authorize the issuance of and to self bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by add Village Treasurer, consistent with the provisions of the Local Finance Law.




