The recent newspaper article concerning the chairmanship and duties of the Allegany County Legislative CountyOwned Property Committee promots me to express my reason for seeking to be relieved of the duties of chairman of this committee after having served as chairman for over mine years.

This committee has the responsibility for all of the County buildings with the exception of the Highway Shop in Friendship and District Highway Shops. It has charge of the fire and liability insurance program and direct responsibility for the maintenance staff at the county buildings in Belmont and Angelica.

Many day-to-day, on-the-spot decisions must be made in operating this building complex. The maintenance staff of the former county jail and courthouse have been empowered to make purchases of up to \$100 without prior committee approval. Those purchases were signed for by the person making the ourchase and submitted to the committee for payment at its regular monthly meeting.

Larger emergency purchases require committee approval. For purchases of this nature, the maintenance foreman would contact me. If I felt a committee meeting was pecessary, a meeting would be

pecessary, a meeting would be held or the committee contacted by telephone for members' ap-

proval or disapproval.

An annual budget for this committee was established as part of the county's expenditure and it is with pride that I can point out that the committee has not overexpended its budget and on many occasions has had funds to return to the County Treasurer.

My resignation from the committee came about in the following way.

With the construction of the new office building and the transferring of the maintenance staff from Angelica to Belmont, the maintenance staff rose to line. With this number of workers, and the responsibility of a multi-million dollar complex, the Board of Legislators felt that it was necessary to create the position of a building maintenance supervisor to oversee the daily operation of the County Buildings. This position requires that a person filling it has charge of the maintenance personnel and complete charge of the county building in all maintenance procedures. plete charge of the county building in all maintenance procedures. This position also demands that the person filling it be someone with a thorough knowledge of building cleaning practices; supplies and equipment; good knowledge of the tools; a working knowledge of the operation and maintenance of an automatic boiler; ability to plan and supervise the work of others; ability to get along well with others; good judgement; experience in cleaning and maintenance work and experience in mechanical and construction trades.

A well-qualified man, Mr. Peter Unfus of Belfast, was appointed to this position by the County-Owned Property Committee on Jan. 3, 1977. This appointment was my last official act as chairman.
