Thru the alertness of one of our village Board Members, it was learned Members was accepting work projects from villages and Towns in the County to be funded in part by a \$200,000 C.E.T.A. grant to increase employment. Thus, Tuesday morning bright and early, we picked up applications for three projects and started digging out the information since the dead-line was Wednesday afternoon at 5 p.m. Thru the fine co-operation of

was Wednesday afternoon at 5 p.m. Thru the fine co-operation of two Village Employees and a great bit of assistance and time spent by a local contractor, we managed to get all three applications filled but typed up and hand delivered Wednesday afternoon with 16 minutes to spare.

One project which we classified as an environmental problem was the drainage problem that exists near the Town Sheds from Baker Street to Rochambeau Avenue that

Street to Rochambeau Avenue that has existed for several years.

Another problem which we classified as a public safety problem was the extension of a 4-inch water line up East Greenwood Street with the installation of a fire hydrant at the end of the line inside the Village Limits to replace a small line which may only be about an inch line.

The third project is of vital concern to the Village since it concerns the building of an addition on to the Village Electric Building so that four of the Village vehicles can have adequate shelter.

All three of these projects need to be take care of as soon as possible with the drainage problem apparently having top priority as far as we are concerned but it was felf that by turning in several projects the Village would have a better chance to have at least one of them funded which could sare the Local Taxpayers at least \$4,000 and thus free a little budgeted noney to put towards these other two.

We were told that we would be informed in the near future as to the disposition of our applications and we hopefully anticipate that it may be as soon as next week. If this should turn out to be the case we can then direct the maximum amount of attention to the compleion of the projects in their due priority.
