Dear Editor

Fellow Republicans:
 Thursday, September 8th is Primary Election Day when you will select your choice of candidates for County positions. I am a candidate for County Legislator from the Towns of Alfred, Almond, Amity, Andover, Burns, Ward and West Almond.

I received my Bachelor of Science Degree from Syracuse University and completed graduate work at Cornell, Alfred and S.U.N.Y.

At the local level of government I was elected to the Belmont School Board for a five year term; am in my third year as an elected Village Trustee (presently Deputy Mayor); was appointed to the Town Planning Board (presently chairman); am an exempt volunteer fireman, having served 15 years.

At the County level, I was the Allegany County 4-H Agent before leaving this position to serve with the United States Marine Corps in the Pacific Theatre during WW II. After service I purchased and operated a dairy farm and re-

turned to teaching Agriculture, Science and Driver Education in Allegany County schools. As elected chairman of the Allegany County Planning Board I have encouraged participation from all interest with in the County; agriculture, industry, small business, education, health, recreation, village and town government. I fully support open meetings and petitions in order that "grass roots" participation take place at all levels of government. My voting record, as a fiscal conservative, indicates a deep concern for meeting the needs of local people.

The prevention and control of flood waters is of major concern to our hamlets, villages and residents in all of our watersheds. This will require the formation of Flood Prevention and Control Districts whose purpose would be to stabilize stream banks, and the establishment of minor impoundments in our tributary streams. Cooperation between our County Soil Conservation District, and the Army Corps of Engineers, the Department of Environmental Conservation, and our local villages and towns and adjacent landowners must be secured.

As your Legislator I will devote the time required to secure the facts and background necessary to make good sensible decisions and consider the impact of any program on our tax structure.

I will appreciate your support and vote at the Republican Primary on next Thursday, September 8th, and dedicate myself to represent you and your community as your County Legislator.
